- 2.) In case of a positive result of the formal check, your application fee of Euro 200.00 is paid in and the management will decide about your participation based on the information about artists and gallery, you sent us.
- 3.) After the confirmation of your participation, the participant has to pay 50% deposit to the organizer. Accepted applications will be countersigned and dated by Lamont AG to become a binding contract.
- 4.) The full prepayment for the exhibition including all the additional services must be done upon final invoice before one month to the fair. The advertisement fee is 600€ and includes two pages in the catalogue with one colour photo.
- 5.) The organizer has the right to cancel the application if the payments are not settled in time. If the exhibitor fails to make the payments, Lamont AG reserves the right to reassign the exhibitor's walls.
- 6.) If after five weeks before the fair the exhibitor informs the organizer that he will be not participating, then has the organizer the right not to return the deposit which was transferred by the participant.
